ORDER

THIS MOTION, made by the Plaintiff for an Order approving the Settlement Agreement executed between the parties on February 13, 2025, an Order approving the proposed Distribution Protocol, and an Order approving the form, content, and manner of distribution of the proposed Notice of Settlement Approval, was heard on July 30, 2025 by hybrid hearing.

3. THIS COURT ORDERS that the form, content, and manner of distribution of the proposed Notice of Settlement Approval, as varied by the previous paragraph, is approved.

4. THIS COURT ORDERS that this action is otherwise dismissed without costs.
